Usage agreement and declaration of consent for customer portal

- 1. Yes, I would like to use the SchwörerHaus online customer portal.

How does registration work?

After your house contract and this user contract with a declaration of consent have been confirmed at the main plant in Hohenstein-Oberstetten, you will receive an email for customer portal registration.

As described in the terms of use, the SchwörerHaus customer portal was implemented with the help of Sharepoint Online. This means that in the next step you need a Microsoft account at exactly the e-mail address that you have given in this form.

If you already have a Microsoft account at this email address, you can use this to register or log in

If not, we ask you to create a new Microsoft account at exactly this email address. The creation and use of this Microsoft account for the customer portal is free of charge.
